Such acquisition, if implemented, may require fund raising by the Company, which may take the form of debt financing, equity financing or other means of financing.

The Board also confirms that, save as disclosed above, there are no negotiations or agreements relating to intended acquisitions or realisations which are discloseable under paragraph 3 of the Listing Agreement.

In the meantime, shareholders are strongly advised to exercise caution in dealing in the shares of the Company.
